Quick FAQ

1 What is WIUS Capital?

An investment brokerage focused on private credit and equity opportunities. We connect investors with real-world, cash-flowing deals — not model portfolios or mutual funds.

2 Who is WIUS Capital for?

Sophisticated and high-net-worth investors (typically \$500k+ net worth, excluding primary residence) who want direct access to private investments — without the high barriers or slow-moving institutions.

3 Are you financial advisers?

No. We're brokers, not advisers. We don't offer advice or push risk-rated portfolios. Instead, we introduce vetted private investments and co-invest ourselves.

4 What makes WIUS different?

We co-invest in every deal. We focus on real cash flow, not speculation. And we do proper due diligence — fast, founder-led, and transparent.

5 What's the typical minimum investment?

Usually between \$25,000 and \$100,000, depending on the deal.

6 How are returns paid?

Returns are paid in the same currency you invested — typically USD, GBP, AED, or EUR — and sent directly to your nominated bank account. We don't touch client money.

7 Can I exit early?

Generally, no. Private credit is illiquid but often transferable. Private equity has no set term and only pays out on exit (sale, IPO, or buyback).

8 How does WIUS get paid?

We're paid by the companies, not you. Our fee may be an introducer fee, profit share, or equity — but your full investment amount is always allocated 100% gross.
